The Senior Business Systems Analyst will plan and lead major technology assignments, analyze complex business and data-processing problems, and recommend improvements to enterprise-scale information systems. This is a hands-on senior role that blends requirements analysis, system design, and process improvement, with opportunities to shape dashboards, data products, and analytics workflows that directly inform program decisions.

Key Responsibilities

- Analyze complex business, scientific, and data-processing problems to implement and improve enterprise computer systems.
- Engage stakeholders to gather, document, and validate user requirements, procedures, and operational workflows.
- Translate business requirements into functional and technical specifications; design solutions that automate or improve existing systems.
- Review and evaluate system capabilities, workflow, integration points, and scheduling limitations; identify bottlenecks and recommend remediations.
- Research and recommend commercially available software and platforms that meet program requirements.

- Design, build, and maintain dashboards, reports, and data products using industry-standard platforms (e.g., Microsoft Power BI, Tableau, IBM SPSS, SAS) in partnership with the analytics team.
- Perform data analysis, quality assessment, and validation to ensure deliverables meet accuracy and reliability standards.
- Plan and lead major technology assignments; function as a technical expert across multiple concurrent project assignments.
- Produce technical documentation, briefings, and recommendations for program leadership and senior stakeholders.
- Coordinate with program managers, functional owners, and cross-functional teams to ensure solutions align with program objectives.
- Mentor junior analysts and contribute to team knowledge-sharing, technical standards, and process improvements.
- Support modernization and integration efforts, including data flows, APIs, and interoperability between enterprise systems.

- Experience with cloud data platforms (AWS, Azure, or GCP) and modern data engineering tools.
